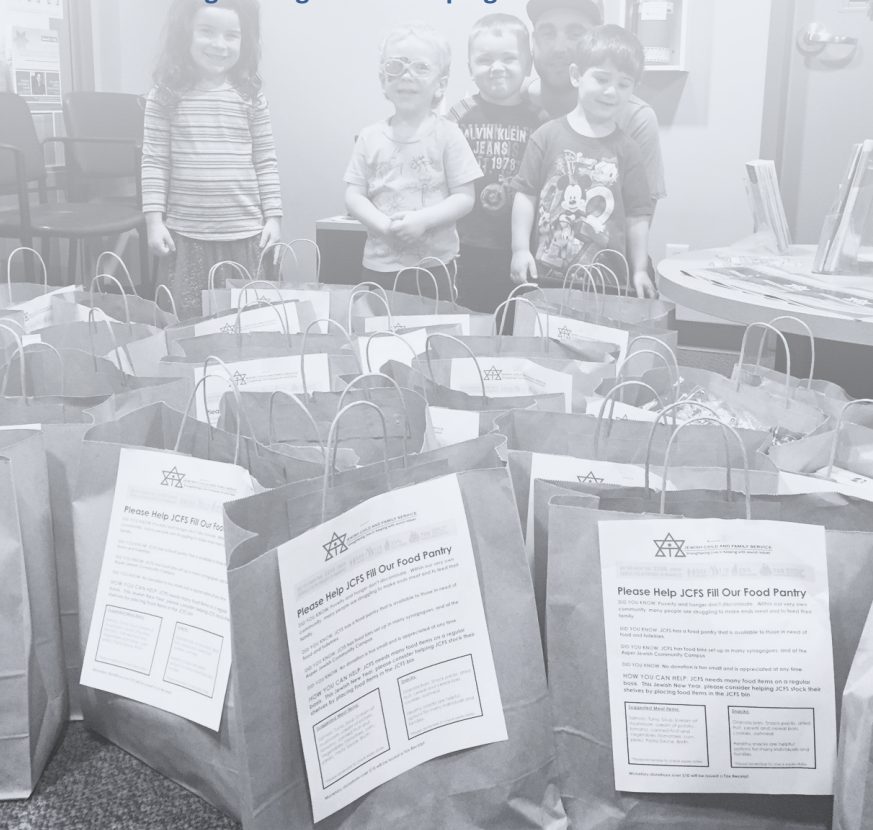

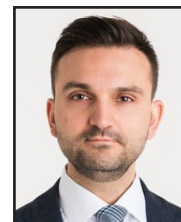

MESSAGE FROM THE EXECUTIVE DIRECTOR



Without a doubt, 2020 has been the most interesting and remarkable year in recent memory. As I reflect back on the impacts, to date, of the COVID-19 Pandemic, it has been a year of challenge, but also a year of perseverance, motivation, adaptation, resilience, and

response. JCFS is proud to have remained true to our mission of Strengthening Lives in Keeping with Jewish Values. Perhaps the most important core values embodied this year were *Connection* and *Community*.

At the time of drafting this message, the Jewish festival of Shavuot is just around the corner. Shavuot celebrates the receiving of the Torah from God, with its teachings, laws, ethics, and unifying values. On this holiday, we not only recount the events that took place at Mount Sinai over 3,300 years ago, but we also strive to reexperience the revelation at Mount Sinai by pursuing ongoing relevance in real-time for the Torah's teachings, applications, inspirations, guidance, and values. Our sages taught that never before in our history were the Jewish people more unified and synchronized as a community than in those moments when the Torah was received.

In many ways, this past year had elements of that; dedicated to supporting our community's most vulnerable and at-risk by working collaboratively, and albeit mostly virtually, to provide connection and a sense of community. We did this by quickly mobilizing our staff to work remotely. While we always prioritize staff's emotional wellbeing, this was even more important this year, where they unwaveringly and seamlessly continued to provide the highest levels of service and care.

We reached out to hundreds of seniors, delivered pounds groceries, provided hours emotional support, offered many virtual programs and groups, acknowledged profound grief and loss, and maintained comfort and security. Our Mental Health program and Substance Use and Addictions Support Services program supported clients during times of elevated feelings of isolation and crisis. JCFS led the way on every night of Chanukah with a Virtual Community Candle Lighting; each night co-hosted by one of our community partner agencies. Together with partners like B'nai Brith Canada, Gwen Sector Creative Living Centre, Gray Academy of Jewish Education, Chabad-Lubavitch of Winnipeg, National Council of Jewish Women, and many more, we insured that Jewish holidays were experienced with deliveries of apples and honey for Rosh Hashanah, *De-Light-ful* care packages for Chanukah, *Mishloach Manot* treats at Purim, and the delivery of 150 Passover Hampers. Our foster children thrived, seniors were supported, food insecurity needs met, addicts found opportunities for connection, new immigrant families arrived and settled, emotional anxieties were calmed, hope was maintained, and lives were strengthened.

My overwhelming pride and gratitude, for making 2020 a success, do not do justice to the depth of caring, commitment, dedication, ingenuity, resiliency, and resolve of our amazing staff, Senior Management Team, and Board of Directors. In the truest sense of community, this was all made possible by all of them, our many partner organizations, valued volunteers, generous donors, steadfast granters, and core funders.

Service in the summer of 2020, I think it is safe to say that the effects of the pandemic on JCFS were top of mind for Management and Board, myself included.

A year later, I am happy to report that JCFS has continued to adapt, operating efficiently and effectively at all levels in its new, primarily remote, working environment. This has been a collaborative effort and could not have happened without the help and great work of many, all of whom deserve our thanks for their efforts in keeping JCFS running, in accordance with its mission, under these challenging conditions.

I would first like to thank the staff of Jewish Child and Family Service for their tireless efforts. JCFS not only remained open during the entire year and transitioned staff to remote service seamlessly, all the while dealing with an increased workload. JCFS saw substantial increases in many of its program areas, particularly Older Adult Services and Addiction Support Services. Staff also increased the frequency of their remote contact with clients, to ensure that the clients had all of the support they needed in lockdown conditions.

I also want to extend a huge thank-you to JCFS's dedicated volunteers, who remained eager to assist this year whenever it was safe to do so, most recently for the delivery of Pesach hampers.

Thanks are also due to the accomplished and responsive JCFS Management team, who have been required to plan and implement the transition to remote work on very tight timelines. JCFS's staff is its key asset. The efforts made by Management several years before the pandemic to move to a human-centered approach for engaging staff and creating a positive work culture are now paying dividends; so much so that Management was again invited to speak to its techniques at the international conference of The Network of Jewish Human Service Agencies, which was held entirely virtually over April 19-22, 2021.

I am also thankful for the dedicated JCFS Board Members, who have continued to volunteer their time, attend meetings, and participate in committees remotely, providing the strategic direction and guidance that Management needs in a timely and thoughtful manner.

Finally, I wish to send out my sincere appreciation and thanks to our donors. Recognizing that there was even more need than usual throughout the not-for-profit world this year, I cannot thank you enough for deciding to support Jewish Child and Family Service. Without your generosity, none of the great things that JCFS does would be possible! With that, I join with the Board in wishing all the best to JCFS's donors, staff, volunteers, and Management for the upcoming year.

SERVICE AREA HIGHLIGHTS

The goals of services provided by JCFS are to enhance quality of life, promote independence, ensure stability, and improve capacity of adjustment and adaptability to ongoing life changes and to support social connections to the Jewish community.



OLDER ADULT SERVICES

Older Adult Services is a program designed to support the needs of Jewish elderly living independently in the community. Services ensure an optimal level of psychological, social, cultural, emotional and physical functioning in clients, thereby maximizing their quality of life and allowing them to remain at home and age in place.

TECHNOLOGY LENDING LIBRARY FOR SENIORS

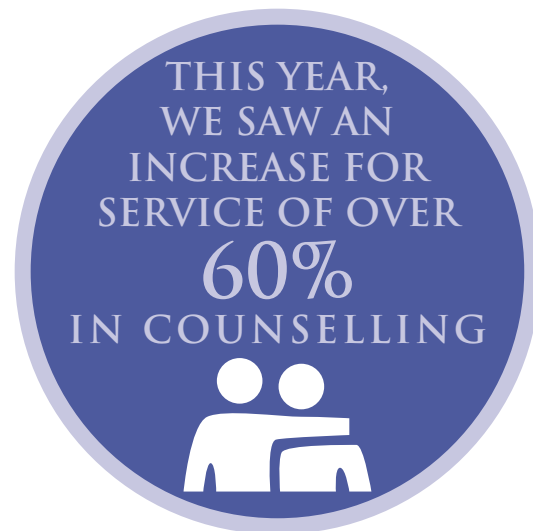
One of our newest programs in Older Adult Services is our Technology Lending Library. JCFS has a cache of iPads that are available for seniors in our program to check out and learn to use alongside a support staff. One such participant is Maria*, and here is her story: Maria has been a participant in the program since its inception. She came into the program with little practice or experience with using internet-based devices and was anxious to learn. Maria hoped our iPad lending program would help her remain connected to her friends, family, and community. Through her technology instructor she quickly moved through learning the fundamentals of the iPad, to using many apps for different programs. Alongside her instructor, Maria practiced using Google to find and navigate online programming, she also learned to search for information about upcoming services offered by her synagogue and the Gwen Sector. Some of the key things Maria and her instructor worked on were using Zoom to connect with the Holocaust Luncheon and the Virtual Holocaust Remembrance Ceremony, accessing Shaarey Zedek services and programs, participating in Gwen Sector programs, navigating and searching for Israeli/Jewish News and Programs, watching movies on Netflix, and using email. Maria now feels confident to use the iPad on her own, and phones in occasionally for minor assistance. Maria uses FaceTime to connect weekly with her children who live outside of the country, and to her children and grandchildren in the city whom she used to enjoy having over weekly for Shabbat dinner. The world that once looked like it would be much smaller for Maria, now is a vibrant virtual community right in the palm of her hand.

COUNSELLING SERVICES

Counselling Services are available to all Manitobans of every religious and ethnic background. This program is one of few in Winnipeg that are offered on a sliding fee scale to remain accessible to as many individuals as possible. Our counsellors are highly qualified in a broad spectrum of therapeutic practices to help support those coping with challenges throughout the lifespan. In addition to individual, couple, and family counselling, we offer therapeutic support groups for those looking for peer and professional support.



NEWCOMER SENIORS SUPPORT SERVICES

Newcomer Seniors Support Services provide support to newcomers over the age of 60, primarily from the former Soviet Union (via Israel), with some from South America. Most are the elderly parents of our community's younger new immigrant families, welcomed by the Federation's Grow Winnipeg initiative. On a weekly basis, these seniors have access to integration programming. A cultural musical choir, summer activities and programs are also offered in partnership with the Rady JCC, Gwen Secter and Adas Yeshurun Herzlia Synagogue.



AGING MENTAL HEALTH SERVICES

Aging Mental Health is a focused program that addresses the needs of our aging clients who also are living with mental illness and/or other chronic emotional problems. This area provides highly specialized, cross-program services to clients requiring unique supports for a variety of issues, including those arising from psychiatric illness, memory loss and isolation.



CHAPLAINCY PROGRAM

The Chaplaincy Program provides pastoral care, support, spiritual guidance, and peace of mind, under the supervision of an ordained Rabbi at times of hospitalization, institutionalization, or incarceration. The Chaplain also educates hospitals and institutions on the spiritual and cultural needs of Jewish patients/residents.



MENTAL HEALTH SUPPORT SERVICES

Mental Health Services are provided within the context of the Mental Health Recovery Model and are individualized and flexible. Approached through a holistic lens, JCFS Mental Health Support Services are offered in keeping with to Jewish cultural and spiritual values.

SOCIAL CONNECTIONS GROUP became part of the Mental Health Services fabric when in-person connections were no longer possible. A group of participants get together on a weekly basis to engage in an activity like painting, play a game (Scattergories is a favourite for many), or celebrate the holidays. Every get together always includes an element of “show and tell” where the participants share something that they are passionate about. Sid* participates in the group every week without fail. He was very active in the community as a volunteer and really started to feel isolated during the pandemic restrictions. Sid channeled his energy into sharing his interests and entertaining the group. From sharing a fun fact he learned for the group to discuss to showing off his impressive plant collection and even sharing his musical talents with a performance or two...Sid always brings joy to this virtual space. He even works to connect with other participants outside the group time together.

VOLUNTEER PROGRAM

The JCFS Volunteer Program is essential to JCFS by providing invaluable underlying supports to all program areas. Volunteers provide numerous supportive activities to the agency. Through the Bikkur Cholim program, specialized volunteers receive best-practice training for providing emotional support and spiritual care visits as adjunct supports to the Community Chaplain.

FINANCIAL ASSISTANCE

Financial Assistance helps community members presenting with monetary needs and struggles, through the core Jewish value of Tzedakah. JCFS administers several short-term financial assistance programs, as well as the Asper Helping Hand interest-free loan program. Financial assistance also is made available from directed funds at the Jewish Foundation of Manitoba, Jewish Federation of Winnipeg and the Holocaust Claims Conference, as well as the Passover-Maot Chitim fundraising initiative.



SETTLEMENT, RESETTLEMENT AND INTEGRATION SERVICES

Settlement Services assist and support newcomer families in their settlement to Canada, and to the Winnipeg Jewish community. This program provides information and support to those preparing to come to Canada and then upon arrival in Winnipeg, help guide, support and connect newcomers throughout the journey.

Integration Services assists newcomers who arrive in Winnipeg with integrating into the Winnipeg community and Jewish community. Connecting people with schools, synagogues, child and youth programs, and kosher facilities are all part of supporting individuals and families to establish lives here in Winnipeg. In cooperation with other Jewish community organizations, Integration Services plays a part in helping newcomers make new friends and establish meaningful connections.

Newcomer Employment Services provides jobs seekers with a wide range of support in their job search process from networking, to referrals, to job seeking information and resources.

The Resettlement mandate provides support for resettlement needs of refugees privately sponsored through Jewish community efforts. We are currently continuing our work with Operation Ezra to support Yazidi families resettling in Winnipeg.





CHILD WELFARE PROGRAM

The JCFS Child Welfare Program is fully mandated under the Child and Family Services ACT of Manitoba to provide voluntary supports and protection services to Jewish children and their families in Manitoba. As a child welfare agency, JCFS is committed to keeping children safe while employing a strength-based approach that builds respectful partnerships with the families and children being served. The program assists families dealing with all forms of abuse and/or neglect, where the safety of children is at risk.

SAM* is a child who used to be afraid of everything. Even being outside on a beautiful day was terrifying. Then he met his worker with JCFS, who cared, supported him, and got him the help he needed to move forward. Now, he can identify his needs and feelings and express them in healthy ways. He's willing to try new activities and has the confidence to make friends. Sam is experiencing new adventures and can't wait to see what happens next!

FOSTER CARE AND ADOPTION SERVICES

Foster Care program at JCFS is a vital component of our Child Welfare program. Foster families are supported through the agency with resources to help a child in care grow and thrive in a loving home while separated from his or her own family.

Through Adoption Services, JCFS assists and supports individuals and families considering the choice of parenthood through adoption, and offers a full range of mandated pre and post adoption services. JCFS also assists adult adoptees seeking information through the Province of Manitoba Post-Adoption Registry, and birth parents seeking support before and after surrendering parental rights.



HOLOCAUST SURVIVOR SUPPORT SERVICES

Holocaust Survivor Support Services address the needs of Holocaust survivors by assisting with the complex and emotional details of Holocaust reparation claims, and providing financial assistance and supplemental homecare via funding received from the Holocaust Claims Conference. Services also include supportive integration groups such as: Reaching Out- Holocaust Survivor's Group, and Paradise Found- a group providing social connection and Jewish education to Russian Holocaust survivors.





SUBSTANCE USE AND ADDICTION SUPPORT SERVICES

Substance Use and Addiction Recovery Services provide supportive services to Jewish individuals living with an addiction or substance use disorder, family supports, and advocacy/awareness building within the community.

We hosted our first CRAFT group for families supporting a loved one struggling with substance use and addictions.

We hosted our first virtual substance awareness series on overdose, harm reduction, and gambling.
